Youth Substance Use Prevention: Center for Prevention Services has been providing youth substance use prevention in the Charlotte region since 1971. We currently serve six counties in North Carolina; Mecklenburg, Union, Stanly, Cabarrus, Rowan, and Davidson. Through Substance Abuse Prevention Block Grant (SAPBG) funding, we supply community education, Synar-mandated merchant education, environmental prevention efforts, and support for substance use prevention coalitions across our six county catchment area. We offer evidence-based educational programs for youth and their families including Strong African American Families, Unique YOU, Too Good for Drugs, AVOID Vapes, and many others. Research has shown that between the ages of 13 and 21, the likelihood of lifetime substance use disorder decreases 4 to 5 percent for each year that the initiaiton of substance use is delayed (Jordan and Anderson, 2017).

4b (Code:) (Expenses \$ 518,944 including grants of \$) (Revenue \$)

Queen City Harm Reduction (QCHR): QCHR provides syringe access services primarily to Mecklenburg County residents and does limited outreach in surrounding counties. We also provide support and education to other counties who wish to start their own syringe access programs. The purpose of syringe access programs is harm reduction and individual empowerment. We provide practical strategies to improve the health of people who use drugs by providing sterile injecting equipment. Syringe access programs are a proven method to prevent the spread of diseases like HIV, HepC, and endocarditis. Safer equipment also means fewer abesses and other health problems that put a strain on health departments and other public resources. Syringe access programs improve the lives of people who use drugs and reduce overdose deaths. QCHR is supported by grant funding from the the NC Department of Health and Human Services and a number of private grants including Novant, Gilead, and HepConnect.

Critical Time Intervention (CTI) Transitional Housing: In 2023-2024, Center for Prevention Services and QCHR initiated a CTI Transitional Housing program for syringe access program participants. This housing program assists people who are currently homeless, have unstable housing, are in danger of losing their housing, or are transitioning from incarceration. Participants receive support for deposits, rent, utilities, appliances, and furniture to get them established in safe housing. As they are able to accept more responsibility for these expenses over the course of several months, they are transitioned out of the program. Currently, we have 40 individuals and families in the program and many who have transitioned out of the program and are self-sustaining. This program is funded through McKinsey Social Responsibility grants, grants from NCDHHS, Mecklenburg County contracts, and grants from Opioid Settlement Funds.

This was the first substance use prevention coalition in North Carolina that was focused on youth substance use and adult substance misuse in the Spanish speaking community. The Latino Department at Center for Prevention Services was established to support Alianza and seek additional grants to expand Spanish speaking services across the county. The Latino Department is funded by grants from Drug Free Communities, STOP Act, Mecklenburg County ABC Board, the North Carolina Behavioral Health Initiative, the Prevent Underage Drinking Initiative, and Blue Cross Blue Shield. With this funding we provide culturally relevant education programs, such as Familia Adelante, and youth education programs that get young people involved in the prevention of substance use. OTHER PROGRAM SERVICES 5: Critical Time Intervention (CTI) Transitional Housing: In 2023-2024, Center for Prevention Services and QCHR initiated a CTI Transitional Housing program for syringe access program participants. This housing program assists people who are currently homeless, have unstable housing, are in danger of losing their housing, or are transitioning from incarceration. Participants receive support for deposits, rent, utilities, appliances, and furniture to get them established in safe housing. As they are able to accept more responsibility for these expenses over the course of several months, they are transitioned out of the program. Currently, we have 40 individuals and families in the program and many who have transitioned out of the program and are self-sustaining. This program is funded through McKinsey Social Responsibility grants, grants from NCDHHS, Mecklenburg County contracts, and grants from Opioid Settlement Funds.
